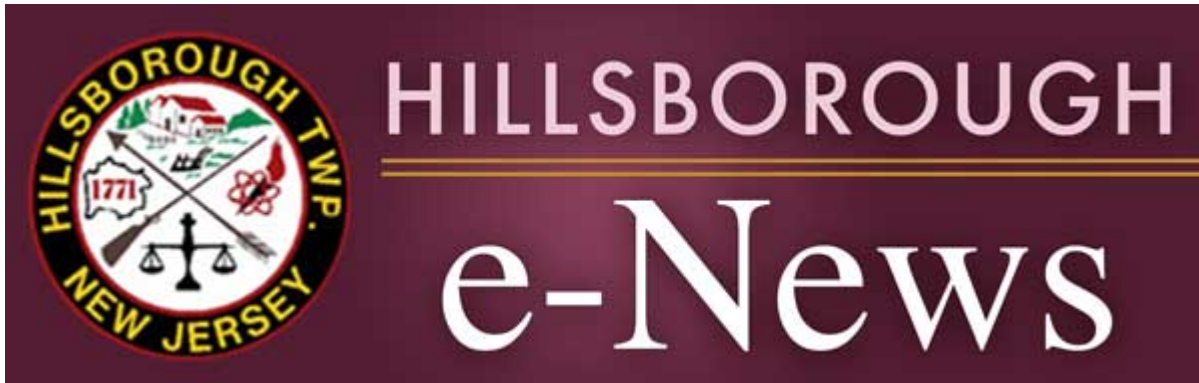

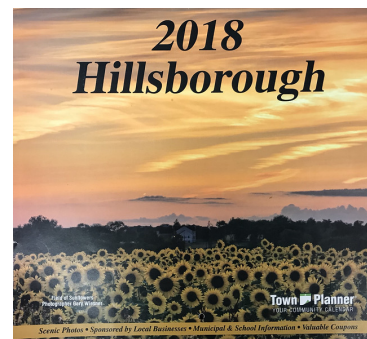

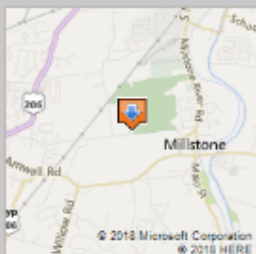

## Department Updates

### Building Department

#### *Things to Know if You Are Planning to Install a Deck*

This summer, if you are planning on installing a deck, there are a few things you need to know.

First visit the Hillsborough Zoning Department to obtain a Zoning permit. Before submitting to the Building Department, it is suggested that you pick up a handout for deck installations and read it through carefully. The Building Department application will require the following documents:

- Zoning approval
- Permit application folder
- Building Subcode Technical section (tech card). Please note that additional tech cards may be required if you are installing Electric or Plumbing.
- If you have hired a builder, include a copy of the Home Improvement license
- 2 copies of plans are required (plan requirements/details are in the Deck Handout). In New Jersey, only home owners and design professionals (i.e - architect or engineer) are allowed to draw these plans. Your contractor is not permitted to draw the plans.

### Engineering

#### *New Amwell Road Repavement - Residents Should Schedule New Utility Hook-Ups ASAP*

The Engineering Department would like to inform residents that New Amwell Road will be repaved in the next few weeks. The Township requests that residents who live on the section of roadway being repaved and that have planned new utility hook-ups to their homes should arrange for them to be completed ASAP. Utility hook-up usually requires an excavation of the roadway and the Township requests this to be completed prior to the repaving.

Additionally, deteriorated curbs on the section of the roadway being repaved will be replaced. Affected residents will be without use of their driveways for approximately 3-5 days. Residents will be notified of parking arrangements.

## Health

### Lyme Disease Prevention

Warm weather is finally here and we are all spending more time outdoors. Although we are getting fresh air and exercise, we are also exposed to ticks which carry disease. The most prevalent tick borne disease is Lyme Disease, which is carried by the Deer Tick, otherwise known as the Black Legged Tick. ### Heatwave Safety

In recent years, excessive heat has caused more deaths than all other weather events, including floods. A heat wave is a prolonged period of excessive heat, generally 10 degrees or more above average, often combined with excessive humidity.



To prepare for a heat wave:

- Listen to local weather forecasts and stay aware of upcoming temperature changes.
- Be aware of both the temperature and the heat index. The heat index is the temperature the body feels when the effects of heat and humidity are combined. Exposure to direct sunlight can increase the heat index by as much as 15° F.
- Discuss heat safety precautions with members of your household. Have a plan for wherever you spend time and prepare for the possibility of power outages.
- Check the contents of your emergency disaster kit (bug out bag) in case a power outage occurs.
- Know those in your neighborhood who are elderly, young, sick or overweight. They are more likely to become victims of excessive heat and may need help.
- If you do not have air conditioning, choose places you could go to for relief from the heat during the warmest part of the day (schools, libraries, theaters, malls).
- Be aware that people living in urban areas may be at greater risk from the effects of a prolonged heat wave than are people living in rural areas.
- Get trained in First Aid to learn how to treat heat-related emergencies.
- Ensure that your animals' needs for water and shade are met.

### Temporary Handicap Parking Permits

Residents with a temporary disability can apply for a Temporary Disabled Parking Placard that is valid up to 6-months, and must apply in person to the Police Department. However, the Police Department obtains the placards from the NJDMV, and they are currently behind on their shipments of placards. Residents applying for placards can expect a delay in receiving it until the problem is rectified at NJDMV.

According to a recent COUNTRY Financial Security Index® report, although individuals 18 and older are culturally considered to be an adult, financial independence is not being reached by the current

generation until age 25 or older by one third of the population. Additionally, according to this 2016 Forbes survey, many respondents felt unprepared for adulthood following educational pursuits, including 43 percent wishing they had learned how to invest, 40 percent wishing they had learned how to do taxes, and 26 percent wishing they had learned how to manage monthly bills.

As a response to this need, the Somerset County Library System of New Jersey (SCLSNJ) will be hosting a series of programs geared towards teens and young adults. The programs will touch on the topics of job preparation, leadership, financial literacy, and more.

"We are finding that many teens today don't know how to cook, change a tire, balance a checkbook, or apply for a job, but are eager to discover how to do these things. While schools prepare them for college and careers, we want to help prepare them for life. In Adulting 101 programs, teens will learn different life skills which will grant them the ability to enter adulthood with confidence," said Christine Jansen, young adult librarian at SCLSNJ's Hillsborough Library branch.

Participate in New Recycling**

## Collection System Pilot Program

Somerset County is piloting a new recycling collection system, and some areas of Hillsborough have been chosen to participate in the program. Check the map of the participating area below to see if you will be part of this program. Participants will receive a letter in the mail detailing the program and will receive two new 65 gallon recycling "totes" - one for paper and one for commingled items.

The equipment that will collect these totes will employ a state-of the-art truck that not only services customers quickly, but also addresses the safety and health concerns of employees. The new technology eliminates the need to physically lift and dump the totes, reducing many injuries, particularly to the back and shoulder areas.

## DUAL STREAM PILOT PROGRAM

The Somerset County Recycling Division is providing two 65-gallon wheeled recycling totes to residents. Each tote has a different color lid (yellow and lime green). Stickers on the lids indicate what materials are to be placed in the totes.

Regular scheduled pickups with the new totes **will begin on your next scheduled recycling date after delivery of totes.**

The tote with the lime green lid is for the cardboard and paper products, and the tote with the yellow lid is for commingled glass, cans, and plastic materials.

**Accepted items are as follows for the paper tote (lime green lid):** Newspapers, inserts, junk mail, magazines, catalogs, envelopes, paperback books, corrugated cardboard, colored paper, clean pizza boxes, office and school papers, shredded paper, chipboard boxes including cereal, cookie, pasta, cake, cracker, detergent (remove plastic liners), gift, shoe, shirt and any retail boxes, paper egg cartons, paper bags, books (hard covers must be removed), phone books, non-metallic gift wrap and greeting cards.

**Accepted items are as follows for the commingled tote (yellow lid):** Aluminum, steel and bimetal cans, glass bottles (all colors), glass jars (all colors), plastic bottles and containers #1 - #7 (Examples: water, soda, milk, juice, soap, detergent, bleach, shampoo, and cleaning-agent bottles). You may also include peanut butter, yogurt and diaper-wipe containers, margarine tubs, plastic trays and clear plastic clamshell containers from restaurant salad bars.



## Annual Vegetation Management Aerial Patrols to Begin July 9th

FirstEnergy/ JCP&L Transmission Vegetation Management will be conducting Annual Vegetation Management Aerial Patrols. Patrols are intended to identify conditions that may be a threat to the safety and reliability of the transmission system.

Please be advised that the Haverfield Aviation will be the helicopter company assisting in the inspections on all JCP&L Transmission Lines, beginning (projected) July 9, 2018 through July 10, 2018, weather permitting.



The pilot will be in communication with any local airports, when in their airspace. The helicopter will be flying at a speed of about 35-40 mph above or alongside the lines and may circle around for a closer inspection.

The U.S. flag stands for our nation and the shared history, pride, principles, and commitment of its people. When we properly display this powerful symbol, we signal our respect for everything it represents.



The flag shouldn't be flown in inclement weather unless it's an all-weather flag.



Flags displayed at night should be properly illuminated.




In a time of national mourning, hang the flag at half-mast.


The flag can be flown every day, but it is often flown to show patriotism on these observances:

New Year's Day	Memorial Day	Constitution Day
Inauguration Day	Flag Day	Columbus Day
Lincoln's Birthday	Independence Day	Navy Day
Washington's Birthday	Labor Day	Veterans Day

## WHEN DISPLAYING THE FLAG...




From your porch, place the union (blue section) at the peak of the staff.




Against a wall or on a window, place the union (blue section) at the top left corner.




On your vehicle, clamp the staff to the right front fender.




With another flag, place the U.S. flag to your left when crossed.



Keep your flag completely dry and folded properly — into a triangle, with the union (blue section) visible — before storing it in a well-ventilated area. If the flag is damaged or worn out, it should be disposed of with dignity.



The flag should not touch anything below it or rest on the ground.

# Poles and Posters Don't Mix

If you are planning to use a sign to publicize any activity, please post it on a stake, not on a utility pole.

**Nails, staples or other fasteners used to attach signs to poles can be hazardous to our workers** who must climb these poles to repair or maintain our equipment.

In addition, **state law prohibits the posting of signs or outdoor advertising on any utility poles.**

If you want to advertise your event, get permission from property owners to post your signs on stakes, and check with your local municipality on any regulations your town may have about posting signs.

### Special Olympics Mission

### Vouchers Available for Eligible Residents at Manville's Farmers Market

#### ***\*\*Hillsborough Residents Must Apply at Hillsborough Township Social Services Department\*\****

Somerset County Freeholder Deputy Director Brian D. Levine wants all county residents age 60 and above to know that on **Friday, July 6**, the Somerset County Office on Aging & Disability Services will distribute vouchers at a local farmers market. Eligible county residents can apply to receive the vouchers on a first-come first-serve basis.

Interested individuals can apply at the **Manville Farmers Market**, located at 279 S. Main St., between the corners of North Orchard and Rosalie Streets, from **12 to 5 p.m.** To be eligible, applicants must reside in Somerset County, be age 60 and above, and show proof of age and residency with a valid driver's license or other documentation.

#### **Income Guidelines**

Applicants must be able to show proof of all income with a current income tax return, W-2 (please make sure "W-2" stays on the same line), most recent pay stub, a social security award letter and proof of pension. An individual's income cannot exceed \$22,459, and a married couple's income cannot exceed \$30,451. Bank statements are not considered a valid proof of income.

#### **Social Security Recipients**

Individuals who receive social security must bring a copy of their Social Security Award Letter. In order to obtain a copy of the letter, contact the Social Security Office located at **245 US-22, Suite 207, Bridgewater, New Jersey, 08807** or call 1-800-772-1213.

#### **Unable to Apply In-Person**

Applicants who cannot apply in-person, may send a representative/proxy who is at least 16 years of age and has valid identification. The representative/proxy should also have a proxy letter that must be signed and dated by the applicant, and stating that the individual is authorized to pick-up the voucher. In addition, the proxy/representative should bring all of the applicant's required items that are listed above. A proxy form can be obtained in advance by contacting the Somerset County Office on Aging & Disability Services at 1-888-747-1122, or **908-704-6346**.

### How to Deal With Hot Summer Days

Residents are encouraged to take measures to stay hydrated and as cool as possible during this stretch of summer heat.

Freeholder Patricia L. Walsh, public health and safety liaison; Freeholder Brian D. Levine, human services liaison; and the Somerset County Department of Health want to share the following tips for preventing heat-related illness:

Keep cool; stay indoors during the hottest times of the day; seek air-conditioned locations, such as libraries and malls; take cool showers or baths; limit outdoor activities to the morning and evening hours; avoid direct sunlight; wear loose, light-colored clothing; and use a shade hat or an umbrella to block the sun.

Drink plenty of fluids to replace what you lose through sweat. Don't wait until you're thirsty to drink; avoid alcohol, caffeinated beverages and sugary drinks; bring a beverage with you to sip frequently when outdoors.

If you have a health condition that requires that you limit fluids, talk with your doctor about your particular situation. Be aware that some medications can increase sensitivity to the heat. Unless directed by a health care professional, do not take salt tablets or use products that may interfere with your medications or adversely affect your medical condition. Always check with your doctor and/or pharmacist.

Individuals age 65 and older are more prone to heat stress than younger people because they are not able to adjust to temperature changes as well. Adult seniors also are more likely to have a medical condition or take medications that impair the body's ability to regulate its temperature.
