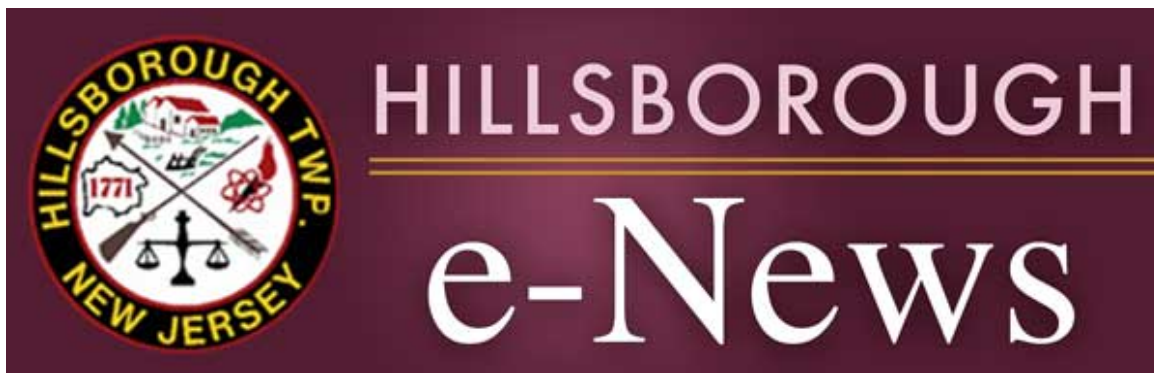

- **Municipal Court:** All Hillsborough, Montgomery and Manville Municipal Court sessions have been canceled through 4/26/2020. Defendants will be notified by mail of a new court date.
